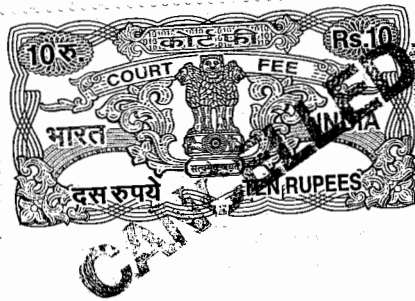

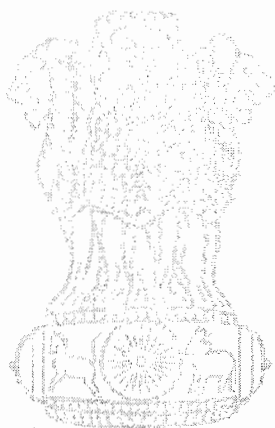
dated 13.12.2013, is restored to its original number. The order dated 13.12.2013 shall be complied with within two weeks from today. No order as to costs.
