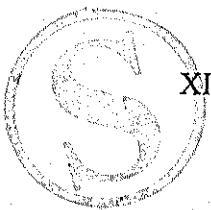

Learned counsel for the petitioner submits that the scheme of grant of scale promotion to remove stagnation is applicable in the case of the petitioner. Similarly situated employees have been granted benefit of scale promotion vide order dated 5th May, 2014 and as the petitioner has remained posted as ASI since 2009, he is also entitled to same benefit. He submits that a representation has been made which is still pending consideration. Learned counsel for the State submits that the petitioner should approach the Inspector General of Police, who is the competent authority to consider such claim. In view of the above, this petition is disposed off at present with liberty to the petitioner to file representation before respondent No.3, who shall consider petitioner's claim for grant of scale promotion in accordance with the Govt. Policy dated 10th August, 2009 and other applicable policies in the matter.
