1. Heard Learned Counsel for the Petitioner and the State.
 2. The challenge in this writ application is to the order passed by the Commissioner dated 19.1.2005 upsetting the order of Collector, Sarguja dated 4.2.2003 by which the latter had cancelled the *Patta* granted in favour of Respondents 4 and 5 for lands alleged to be in long possession of the Petitioner through his predecessors.
 3. Having heard Learned Counsel for the parties, in view of the finding arrived at by the Commissioner that the challenge to grant of *Patta* was itself highly belated 28 years later and that the Collector

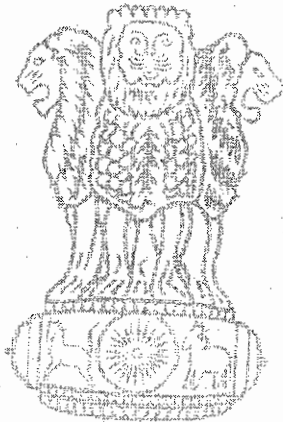
passed the order in violation of the principles of natural justice without issuance of notice to Respondents 4 and 5, the Court does not find any reason to interfere with the impugned order.
