JUDGMENT

The petitioner, the owner of stage carriage No.KL-05-S-6915 applied for temporary permit on the route Village Hall - Kottayam in the vacancy of stage carriage No.KL-05-410. The petitioner has approached this Court with a prayer to direct the respondent to grant and issue temporary permit to the petitioner's stage carriage No.KL-05-S-6915 on the route Village Hall - Kottayam in the vacant timings of stage carriage bearing No.KL-05-410.

2. If vacancy of stage carriage bearing registration No. KL-05-410 is still in existence and no other person having better claim has applied for a temporary permit to operate a stage carriage in that vacancy, there will be a direction to the respondent to issue a temporary permit of four months duration within one week from the date of production of a copy of this judgment by passing appropriate orders on Ext.P1. Needless to say, such issuance of temporary permit will be subject to the preferential claim if any.
