ORDER

(Order of the Court was delivered by N.PAUL VASANTHAKUMAR,
J.)

Heard Mr.P.Ganesan learned counsel appearing for the petitioners and Mr.K.Karthikeyan, learned Government Advocate (Education) appearing for the respondents.

2. This contempt petition is filed for non-compliance of the direction issued in W.P.No.26471 of 2010, dated 22.07.2011 to extend the benefit of G.O.Ms.No.234, School Education Department dated 10.9.2009.

3. During the pendency of the contempt petition, the official respondent has fixed the pay and arrived at the salary payable in accordance with the said G.O.Ms.No.234 dated 10.9.2009 and the actual salary being received by each of the petitioners. Out of 24 petitioners, in respect of petitioner Nos.12,13 and 21 the arrears of salary have been paid and they have also received the same on 14.3.2014. In respect of the remaining petitioner Nos.1 to 11, 14 to 20 and petitioner Nos.22 to 24, who are legal heir of deceased writ petitioner Nos.3,16 and 18 either they are getting more pay or equal pay, while applying

G.O.Ms.No.234 dated 10.9.2009. The individual proceeding of salary payable as per G.O.Ms.No.234 and the actual amount paid to each of the petitioners on their retirement was furnished to the said petitioners.

4. The apprehension of the petitioner Nos.1 to 11, 14 to 20 and petitioner Nos.22 to 24, who are legal heir of deceased writ petitioner Nos.3,16 and 18 is that their pension may be reduced based on the fixation now made in the orders. The learned Government Advocate appearing on behalf of respondent-Education Department submits that there will be no reduction in pension based on the said calculation. The said submission is recorded.

5. Recording the above submission, this contempt petition is closed. If the said petitioners are aggrieved by the orders passed, it is open to them to challenge the same in separate proceedings.
