PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioners apprehend arrest for the offences punishable under Sections 294(b), 323 and 506(i) of IPC in Crime. No. 1263 of 2014 on the file of the respondent police, and seek anticipatory bail.

2. The case of the prosecution is that the due to money dispute the petitioners are alleged to have scolded the the defacto complainant in filthy language.

3. Heard both sides.

4. Considering the facts and circumstances of the case and also considering the submissions made on behalf of both sides, I am inclined to grant them anticipatory bail.

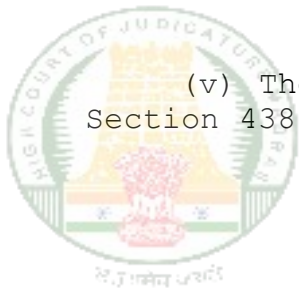
5. Ordered as under:-

(i) Anticipatory bail granted to the petitioners;

(ii) Petitioners shall surrender before the learned Judicial Magistrate-II, Kovilpatti, Thoothukudi District within a period of fifteen days from the date of receipt of a copy of this order, failing which, the petition for anticipatory bail stands dismissed;

(iii) Each of the Petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten thousand only) each with two sureties each for a like sum to the satisfaction of the above said Magistrate;

(v) The petitioners shall comply with the condition stipulated under Section 438 Cr.P.C. Scrupulously.
