(ii) Two sureties, who shall execute a bond for Rs.10,000/- (Rupees Ten Thousand only) each for a like sum to the satisfaction of the learned Judicial Magistrate, Rameshwaram, Ramanathapuram District.

(iii) Petitioner shall report before the respondent police daily at 10.30 a.m. until further orders.
