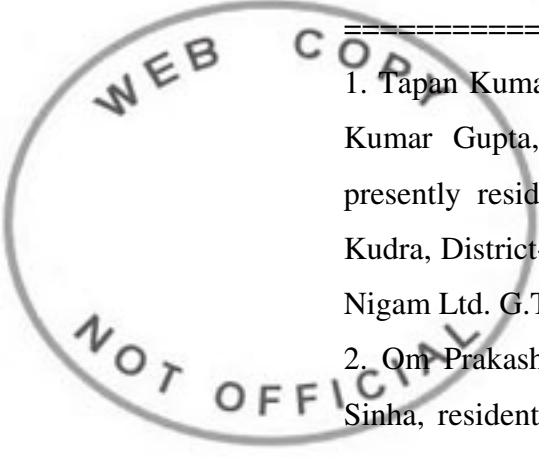


IN THE HIGH COURT OF JUDICATURE AT PATNA

ORAL JUDGMENT

No one appears on behalf of the petitioners. Heard learned counsel representing Bihar Rajya Beej Nigam Limited as well as State.

2. The petitioners seek a direction from this Court to regularize their services as an employee of Bihar Rajya Beej Nigam Limited, under which they claim to have been working for last fourteen years.

3. I do not find any averment in the writ application to demonstrate that the petitioners' initial engagements were made in conformity with Articles 14 and 16 of the Constitution of India. Additionally, I find from the counter

affidavit filed on behalf of the respondents-Corporation that because of the paucity of work in the Corporation and its precarious financial condition, the Corporation is not in a position to appoint or deploy any further employee.

4. I do not find any reason to entertain the relief as sought for in the writ application.

5. This application is, accordingly, dismissed.
