10 23-02-2015 Mr. Ajay Kumar Sinha, learned counsel for the

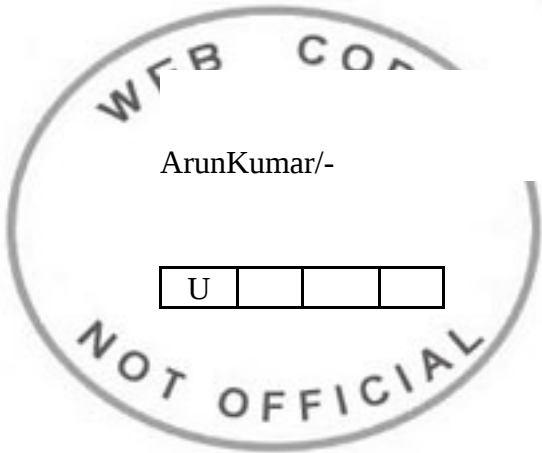
petitioners does not have any specific instruction from his client to
