Learned counsel for the State submits that in
compliance of the order dated 30.09.2010 passed in C.W.J.C. No.
15530 of 2010, which is under contempt, the encroachment in
respect to Khesra No. 2870 as detailed in order under contempt
has been removed, which would appear from paragraph 5 of the
supplementary show cause dated 24.06.2013, which has also been

admitted by the petitioner in reply to the 4th supplementary show cause filed on behalf of the opposite party no. 5.
