Cr. Misc. No.24511 of 2014 has been filed for setting aside the order dated 06.06.2014 passed in Sessions Trial No.320 of 2010 by the Sessions Judge, Darbhanga, whereby he has rejected the application for transferring Sessions Trial No.320 of 2010 arising out of Bishanpur P.S. Case No.58 of 1994 to any other Court.

Cr. Misc. No.33275 of 2014 has been filed for setting aside the order dated 06.06.2014 passed in Sessions Trial No.320 of 2010/Sessions Trial No.326 of 1999 by which Sessions Judge, Darbhanga, has rejected the application for transferring Sessions Trial No.326 of 1999 also arising out of the same case i.e. Bishanpur P.S. Case No.58 of 1994 to any other Court.
