ORAL ORDER

Heard learned counsel for the parties.

Having regard to the nature of allegation against the  
petitioners for offence under Section 147, 148, 149, 323, 384, 387,

435, 427 of the Indian Penal Code and Section 27 of the Arms Act and the fact that the petitioners with others had brutally assaulted a business entrepreneur setting up a sugar mill, this Court is not inclined to grant privilege of anticipatory bail to them.

Accordingly, the prayer for anticipatory bail of the petitioners, namely, Nanhak Rai, Jokhan Rai @ Jokha Rai, Arvind Rai, Shatrughan Rai, Subhash Rai and Munna Rai is hereby rejected.

If the petitioners, however, would surrender before the court below and make a prayer for grant of regular bail, the same shall be decided on merit, preferably on the same day, without being prejudiced by this order.
