ORAL ORDER

Heard learned counsels for the petitioners and the State.

The petitioners are apprehending arrest in a case registered for the offences punishable under Sections 147, 148, 149, 341, 323, 225, 337, 338, 332, 333, 188, 353, 379, 427, 307/511, 171”C”(F) and 120B of the Indian Penal Code.

It is alleged that during the PACCS election, the informant was deputed as Magistrate for conducting peaceful election but 4-5 persons started mounting pressure for casting bogus votes in favour of one of the contesting candidates Md. Khaliq Laddu and on objection being raised, some of the accused pore ink in the ballot box when one Md. Norej was caught when 2-3 persons came and tried to get Md. Norej released on the basis of statement of Md. Norej, 26 persons were named in the FIR.

It is submitted by learned counsel for the petitioners that the accusation is omnibus and general against the mob and except the statement of Norej, no substantial evidence was collected against the petitioner. Statement has been made in para 3 of each petition that the petitioners have no criminal antecedent.

Considering the aforesaid facts, let the above named

petitioners be released on anticipatory bail, in the event of arrest or surrender before the learned Court below within a period of 12 weeks from today, on furnishing bail bond of ₹10,000/- (ten thousand) each with two sureties of the like amount each to the satisfaction of the learned C.J.M., Araria in connection with Raniganj P.S. Case No. C.R. 260 of 2014, subject to the conditions as laid down under Section 438(2) Cr.P.C.
