Heard learned counsel for the petitioner and learned  
counsel for the officials of the Lalit Narayan Mithila University  
(opposite party nos. 2 to 5).

The present contempt application has been filed for  
noncompliance of the order dated 21.01.2010 passed in C.W.J.C.  
No. 1040 of 2010.

Learned counsel for the Lalit Narayan Mithila  
University (opposite party nos. 2 to 5) submits that in compliance
