2 16-12-2015 The instant matter has been filed under the heading for modification of order dated 28.09.2015 passed in Cr.Misc.No.39394 of 2015 whereby the petitioner nos.3, 7, 8, 11 and 13 (Santosh Mukhiya, Sharma Mukhiya, Mukesh Mukhiya, Vijay Sah and Shambhu Mukhiya) respectively have been allowed anticipatory bail.
