Heard learned counsel for the parties.

Obviously, all is not well with the way things are being done, may be with active connivance of certain officials of the Education Department down the line, if the innocent persons have been duped of their hard earned money in the hope of earning a livelihood under the State and there are functionaries of the State who

are involved in such a racket, there is an obligation cast upon atleast the Principal Secretary of the Department of Education, Government of Bihar, Patna to look into the matter deeply and fix responsibility, because atleast the State officials cannot be seen to be part of a racket to fleece innocent citizens of this State, merely because they are desperately looking for employment under whatever form and manner their engagement is made.

The Principal Secretary, Department of Education, Government of Bihar, Panta will ensure that the whole racket of such kind is gone into, reviewed with regard to other districts as well and also take steps for fixing responsibility on the persons so involved within a reasonable time-frame of three months.

Writ application is disposed off with observation as above.
