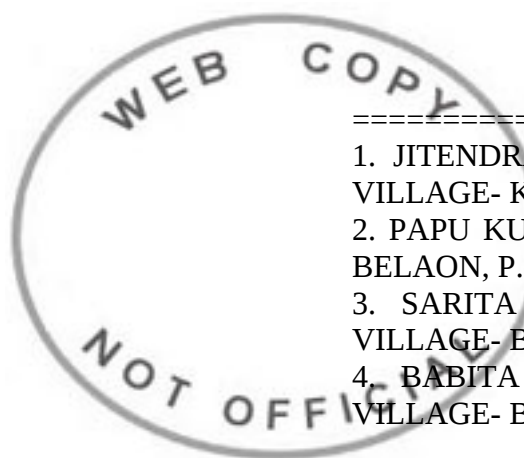

order dated 04.07.2012 passed in C.W.J.C. No. 8487 of 2012. The aforesaid writ was disposed of in the light of the issue decided in L.P.A.
