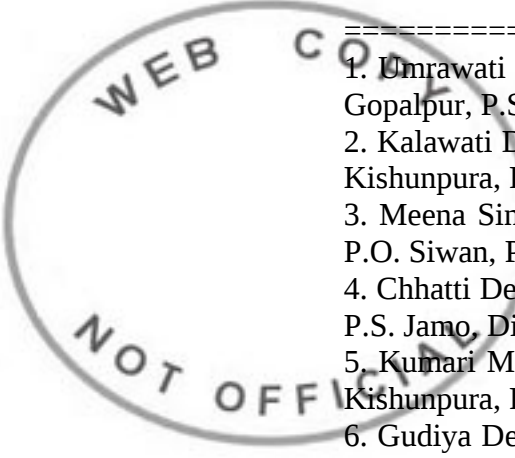
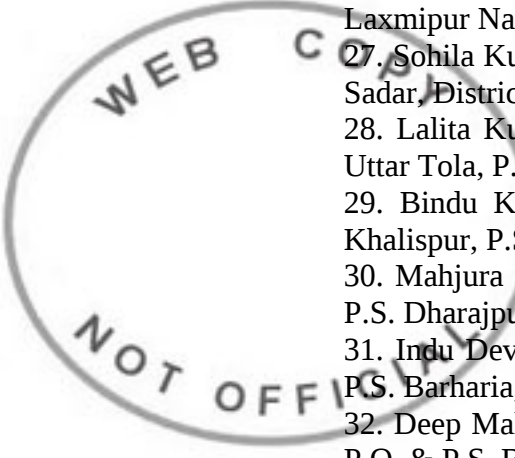

It is the contention of the learned senior counsel for the petitioners that in view of the decision rendered in CWJC No.21251 of 2012 and other analogous cases, decided on 11.4.2013, he would like to withdraw the writ application.
