Petitioners are named in the first information report but they have been made accused in this case only on the ground that on the day of alleged occurrence, they were seen by the informant taking wine at a shop and except the aforesaid material, there appears to be nothing against them.

Moreover, having more or less similar allegation co-accused Kanhiya Yadav has already been granted privilege of bail by a coordinate bench of this court.

Accordingly, petitioners are directed to be released on bail on furnishing bail bonds of Rs 10,000/- each with two sureties of the like amount each to the satisfaction of the Chief Judicial Magistrate, Saharsa in of Sadar P.S. Case no. 455/2010.
