Heard learned counsel for the parties.

Counter affidavit has been filed on behalf of respondents no. 1 and 2 from which it transpires that all dues have been paid to the petitioner, except difference of gratuity. It is submitted that for the same, a cheque was earlier issued but returned undelivered due to which a fresh cheque has been issued in favour of the petitioner under cheque no. 127598 dated 04.09.2015 for Rs. 5560/- drawn on Punjab National Bank, East Gandhi Maidan, Patna Branch which is being handed over to the learned counsel for the petitioner.
