No one appears on behalf of the petitioner.

Mr. Das appears on behalf of the Agriculture Insurance Company (for short 'the Insurance Company') and Mr. S.K. Jha appears for the Managing Director National Central Cooperative Bnak, Bettiah.

The petitioner has prayed for a direction upon the Insurance Company to make payment of the claim amount of the crops insured for the year 2008-09.

A counter affidavit has been filed on behalf of Insurance Company (respondent no.8). On the strength of the communication dated 15.12.2011, annexed with the counter affidavit of the Insurance Company, it has been submitted by Mr. Das that the insured amount has already been credited with the Cooperative Bank for disbursement to the petitioner.

This appears to be the reasons for non appearance of the petitioner as he might have lost interest in pursuing the case. The application is dismissed for want of prosecution.
