No counter affidavit on behalf of the University has been filed till date, even though writ application was filed as far back as on 18.9.2014.

Writ application is disposed of with an observation that the direction issued in the above writ applications will also apply to the petitioners if they also form the ministerial class of employees under the Rajendra Agriculture University.
