Petitioners are Ex-Secretary, Member and Teacher Representative of the Managing Committee of Hari Shankar Verma Co-operative Inter College, Ramgarhwa, East Champaran. They are apprehending their arrest in connection with Ramgarhwa P.S. Case No. 46/15 dated 13.05.2015 registered for the offences under Sections 193, 406, 408, 409, 420, 466, 467, 468,



469, 477, 500, 120(B), 34 of the Penal Code, pending in the court of Sub-Divisional Judicial Magistrate, Raxaul, Motihari, East Champaran.
