ORAL ORDER

2 30-09-2015 Despite repeated calls, no body appears on behalf of the petitioners to press this application. Mr. Saraf, A.C. to G.P. 18 for the State is present.

It has been pointed out that no document showing settlement on permanent basis of the chart land by the Irrigation Department in favour of the petitioner and/or their ancestor has been enclosed along with the writ petition. The State Government have framed Settlement Rules, 2010 and under Rule 2(gha) settlement are being made strictly in accordance with law for a period of three years. The rule framed by the government is also not under challenge.

Be that as it may, since no body has appeared on behalf of the petitioner to press this application, the Court is constrained to dismiss the application for non-prosecution.
