

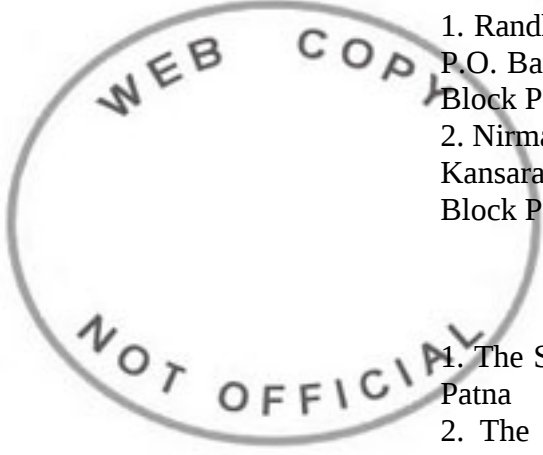

ORAL ORDER

2 27-07-2015 The petitioners seek quashing of the requisition dated 17.7.2013 filed by the ten elected members of Block Panchayat Samiti, Supi to Respondent No.6 whereby after fixing the date for special meeting of Supi Block Panchayat Samiti on 25.7.2013 for consideration of No confidence motion against the petitioners, the Pramukh and Up-Pramukh of the Block Panchayat Samiti.

The petitioners were appointed as Pramukh and Up-

Pramukh and earlier No Confidence Motion which was brought against them was dropped.

The petitioners submit that earlier No Confidence Motion against them was rejected on 10.7.2013. They rightly submit that no new Confidence Motion could have been brought within a year from the date of rejection fixing the special meeting on 25.7.2013. However, no affidavit has been filed as what has happened thereafter.

As by now more than two years have elapsed, this Court is not inclined to entertain this writ application. It is accordingly dismissed. However, liberty is granted to the petitioners to challenge any subsequent order, if so advised.
