Learned AC to PAAG submits that by two letters dated 18.3.2015 and 27.3.2015 received from the Deputy Commissioner of Commercial Taxes (In-charge), Hajipur Circle, Hajipur it has been informed that the Process No. 2721 dated 20.1.2015 for Rs.1,58,920/-, Process No. 2723 dated 20.1.2015 for Rs.18,26,013.17 and Process No. 2724 dated 20.1.2015 for Rs. 28,28,913/- as also Process No. 2722 dated 20.1.2015 for Rs. 3,42,378/- have been withdrawn.

In the aforesaid view of the matter, since the writ applications had been filed for quashing of the reminder/demand issued and raised by the aforesaid four processes, which have been withdrawn by the respondents, the writ applications do not survive. They are, accordingly, dismissed as infructuous.
