Let necessary correction be made in the index relating to Annexure-13

series in I A No. 756 of 2015.

2. I.A. No. 756 of 2015 is allowed.

3. Since the question raised by these petitioners are identical in nature as well as the relief, which was prayed for in a writ application, decided in the case of Dr. Kedar Nath Pandey, which was CWJC No. 7636 of 20914, decided on 15.01.2015, the present writ application is also allowed.
