2 04-08-2015 The petitioner is LTIS consumer having sanctioned load of
 8 H.P. for running a flour mill situated in village Harinagar in the
 district of Khagaria.

The petitioner states that the village where flour mill is
 situated is flood affected area and the supply of electricity in the
 aforesaid area is hardly two hours in a day and sometimes there is

no electricity in whole day. He further states that time and again he has made a prayer for issuance of actual bill and in this regard he has filed a representation but no action has been taken as yet.

Having regard to the facts and circumstances of the case, this writ application is disposed of with a direction to the Assistant Electrical Engineer, Electric Supply Division, Gogri, Khagaria, respondent No.9, to dispose of the representation of the petitioner.
