appointment as Passenger Guards is a lateral entry and the Senior Goods
Guards are not to be subjected to any written test. Such view has already been
affirmed by another Bench of this Court under order dated 09.07.2015 in
C.W.J.C. No.5969 of 2011.

In the circumstances, we do not deem it appropriate to
interfere in the present matter also. Accordingly, the writ petition is
dismissed, however, without any cost.
