before the newly created body, which has been saddled
with the responsibility now for carrying out inspection and

If such an application is made by following the procedure, which may include deposit of certain fee etc., the authority must carry out an inspection within a reasonable time-frame, not beyond a period of three months to make its recommendation for appropriate decision thereafter.
