JUDGMENT & ORDER (ORAL)

(Deepak Gupta, CJ.)

The allegation of the petitioners is that their minor daughter aged less than 16 years has been kidnapped by the respondent No.5. The petitioners along with the petition has also placed on record copy of the written complaint dated 24-05-2014 as well as the FIR No. 10/14 dated 01-06-2014 recorded with the Police Station Chailengta.
