Learned counsel appearing for the parties submit that issue involved in these writ petitions has been considered and decided by coordinate Bench in WP (S) No.6927 of 2011 (Kunwar Kant Dewangan vs. State of Chhattisgarh and others), decided on 6.12.2013. They also submit that against the aforesaid order, writ appeal was filed that was dismissed and against the order of writ appeal, SLP No.16838/2015 was filed by the State Government. SLP filed by the State Government has been dismissed by the Supreme court in the matter of State of Chhattisgarh v. Ku.Harjeet Kaur on 17.8.2015 and as such, order dated 6.12.2013 has attained the finality.

2. In view of above, the petitioners are directed to make representations along with copy of order passed by this Court to respondent No.4, who will verify and consider the claims of the petitioners and take decisions in the matters in accordance with law.
