1. In these writ petitions, the petitioners have called in question the impugned orders whereby their contract appointment on the post of AG-III under the Rashtriya Madhyamik Shiksha Mission has been cancelled on the ground that the post has been abolished for non-saction of funds by the Central Government.
2. After arguing for some time, learned counsel for the petitioners seek permission of the Court to withdraw the writ petitions with liberty to make representation before the competent authority of the State Government in view of the Finance Department letter dated 2.5.2015 (Annexure-P/9).
3. In addition, Shri N. Naha Roy, learned counsel appearing for the petitioners in WPS Nos.1787, 1779, 1783, 1780, 1782, 1777, 1808, 1817, 1812, 1819, 1811, 1816, 1813 & 1820 of 2015 would also seek liberty to move a fresh writ petition with regard to remaining part of the reliefs prayed in his writ petitions concerning the issue regarding appointment of AG-III in the regular set up of the School Education Department, Dhamtari.

4. For the foregoing, all the writ petitions are dismissed as withdrawn with liberty aforesaid. However, in the event, the representation is preferred, the respondents shall decide the same expeditiously.
