1. The present appeal arises from order dated 18.6.2015 disposing Writ Petition (S) No.1995 of 2015 directing that the claim of the Appellants for Kramonnati Vetanman was to be considered in accordance with the State Government's Circular dated 28.4.2015 issued pursuant to the order in Writ

Appeal No.227 of 2015 (Anil Kumar Ramtake v. State of Chhattisgarh) and analogous matters disposed on 23.4.2015.

2. Learned Counsel for the Appellants submits that the circular dated 14.11.2014 was sought to be given retrospective effect which aspect has not been considered in Writ Appeal No.389 of 2014.

3. We have considered the submissions and are of the opinion that the issue sought to be urged on behalf of the Appellants have been fully considered by us in Writ Appeal No.389 of 2014 disposed on 23.3.2015 as clarified on 23.4.2015 in Writ Appeal No.227 of 2015.

4. We therefore find no reason to interfere with the order under appeal. The appeal is dismissed.
