The present petition has been filed for quashment of the charge sheet filed against the petitioner by police station AJAK, Korba in Crime No. 01/2013 for the offences punishable under Sections 294, 506 IPC and 3(1)(V) of the Scheduled Caste/Scheduled Tribe (Prevention of Atrocities) Act, 1989. Lengthy arguments have been advanced by both the parties and during which it has also been informed by counsel for the petitioner that on 3.3.2015, charges have also been framed against the petitioner. In view of this development, State counsel points out that the better remedy for the petitioner would be to challenge the order of the trial judge framing the charge against the petitioner. Counsel for the petitioner submits that he may be permitted to withdraw this petition with the liberty to challenge the order dated 3.3.2015 framing the charges against the petitioner. The petitioner is permitted to withdraw this petition with the aforesaid liberty. At this stage, counsel for the petitioner submits that the Registry be directed to return the certified copy of the impugned charge sheet which has been filed
