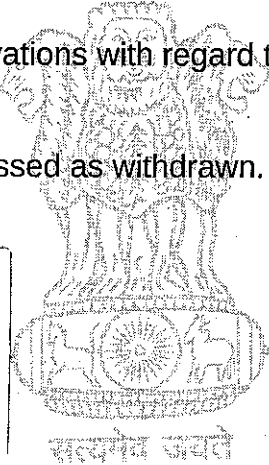
Order On Board
