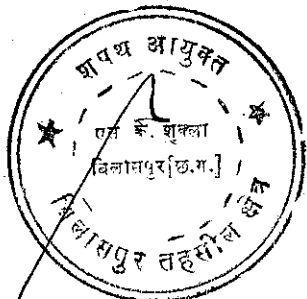

6. W.P.No.2333/2002, dismissed for want of prosecution vide order dated 05.10.2010 by the learned Single Judge, is restored to its original number.

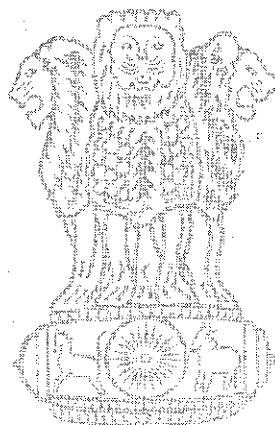
