1. Heard learned counsel for the respective parties.
2. Mr. Kulkarni, learned counsel for the applicants submits that in connected appeals, the court has allowed the applicants to withdraw 80% of the amount deposited on submitting an undertaking to this court and 20% was directed to be kept in fixed deposit. As such, the applicants in the respective applications for withdrawal are allowed to withdraw 80% of the amount deposited on submitting an undertaking before this Court that in
