PER COURT :

1. Issue notice to the respondents. Learned AGP waives notice for respondents 1 and 2. Mr. Dhongade, learned counsel waives notice for respondent No.3- acquiring body.
2. Learned counsel for the acquiring body and learned AGP oppose the applications on the ground that there is abnormal delay and no sufficient cause is stated.

3. Mr. Kale, the learned counsel for the applicants submits that in connected matters, this Court has enhanced the compensation amount after condoning the delay. The learned counsel further submits that to show bonafide, the applicants have filed undertaking that in case enhancement is granted, the applicants would not claim statutory benefit for the delayed period.

4. Considering the aforesaid aspects of the matter and the fact that the reasons given in the applications are not controverted by filing affidavit so also considering the bonafide shown by the applicants to wave statutory benefit for the delayed period, the civil applications are allowed. Delay condoned.

5. Civil applications are accordingly disposed of. No costs.
