. The prayer is made for continuation of the stay and for time to deposit the amount. The time granted by this court to deposit the amount has already lapsed long back. Even subsequent applications are also rejected. It is submitted that, the amount was required to be diverted for the drought affected areas and could not be deposited.

2. In case the applicant deposits the amount within a period of four (4) weeks from today, the stay granted earlier shall

continue to operate till the disposal of appeals. In case the amount is not deposited, within four (4) weeks from today the stay shall remain vacated. The civil applications are disposed of.
