6] Mr.Koralkar, learned counsel for the respondent/claimant makes a statement that in the sister appeal i.e. First Appeal No.3026 of 2013, stay was granted on the condition of deposit of the entire amount under the award, together with up-to-date interest.

7] In the circumstances, similar order is passed in the present applications also. Stay to the execution of the impugned awards is hereby granted in each of the applications, on the condition that the applicants deposit entire amount under the impugned award, together with up-to-date interest, within twelve weeks from today. The applications for grant of stay stand disposed of accordingly.

8] The First Appeals are **admitted**. Mr.Koralkar, learned counsel waives notice for the claimant. Learned AGP waives notice for respondents – State.
