. The learned counsel for the Applicants/Appellants submitted that the valuation of these 18 suits are below Rs.1 Crore. Therefore, he prays that these Appeals needs to be transferred to District Court, Alibag in view of the notification issued by Law and Judiciary Department dated 31st August, 2015.

2. As per the Notification No.CCS.2014/C.R.-25/D-19, dated 31st August, 2015, the suits having valuation upto Rs.1 Crore are to be transferred to District Court with effect from 1st September, 2015. Hence, these Appeals are transferred to District Court, Alibag. Earlier order, if any, to continue till then.
