3 As all the Petitioners are Shikshan Sevak, We are inclined to dispose of all these Writ Petitions, specifically in view of the order passed by the Division Bench of this Court (Coram:-Anoop V. Mohta & K.R. Shriram, JJ.) in Dadade Khanderao Vithoba & Ors. Vs. The State of Maharashtra, Writ Petition No. 3037 of 2015 and other connected matters, dated 13 April 2015, in similarly situated matters, whereby we have directed to decide the applications for approval so filed by the respective Petitioners. Therefore, by keeping all points open and as both the counsel have conceded the said position, we are inclined to dispose of all these Writ Petitions by passing the following order.

#### **ORDER**
