1). This Miscellaneous Civil Application filed under Section 24 Civil Procedure Code is for transfer of M.J. Petition No.A-371 of 2014 pending in the Family Court, Bandra, Mumbai to the Court of Civil Judge Senior Division, Ahmednagar, where the applicant wife is presently residing. The marriage of the applicant and the respondent had taken place on 24<sup>th</sup> April, 2012. A daughter, Diksha was born to them on 22<sup>nd</sup>

June, 2014. One of the grounds for transfer set out in the application is that the child being in the care and custody of the applicant, it is difficult for her to commute between Ahmednagar and Mumbai for attending to the Court proceedings. Considering the age of the child and the specific difficulty relating to the child, the application is allowed in terms of prayer clause (a).
