Heard Mr. Shirish Gupte for the petitioners in Writ Petition No. 4196 of 2012, Mr. Mahesh Jethmalani for petitioners in Writ Petition No. 4197 of 2012, Mr. Ponda on behalf of petitioner in Writ Petition No. 4228 of 2012 and Mrs. Mrunalini Deshmukh, learned counsel for the respondents in all the petitions.,

2. Learned senior counsel Mr. Gupte and Mr. Jethmalani have submitted that they have to argue some issues which are left out and could not be argued on the earlier dates. At the same time, Mrs. Deshmukh, learned counsel for the respondents has also not completed her arguments. In view thereof, petitions will have to be adjourned.
