Since these matters are pending for long time, we direct that within a period of four weeks from today, all parties shall comply with the office objections and thereafter the matters can be placed in the regular course for hearing and final disposal. Needless to clarify that if within four weeks the office objections are not complied with, each of the Notice of Motions will stand dismissed without further reference to the Court. What is already disposed of will not be covered by this order.
