That convening and holding the meeting of the secured Creditors of the Applicant Company, for the purpose of considering and if thought fit, approving with or without modification(s), the cheme of Arrangement and Reconstruction of Citi Lands And Leisure Private Limited, Transferor Company No. 1, Binod Ferro Alloys Private Limited, Transferor Company No. 2, Shyampriya Credit Capital Private Limited, Transferor Company No. 3 Supreme Construction And Developers Private Limited, Transferor Company No. 4 with Flex Mercantile India Private Limited, Transferee Company, is dispensed with and in view of the Consent given the sole secured creditor of the Applicant Company which are annexed as Exhibits 'V' to the Affidavit in Support of Summons for Directions.
