UPON the application of the Applicant Company above named by a Summons for Direction AND UPON HEARING Mr.Karthik Somasundram instructed by M/s. Krishnamurthy and Co., Advocates for the Applicant Company, AND UPON READING THE AFFIDAVIT DATED 23rd December, 2014 Mr. Jaymeen Shah, Authorised Signatory of the Applicant Company, in support of the Summons for Directions and the Exhibit therein referred, IT IS ORDERED:-

1. That the convening and holding of the meeting of the Equity Shareholders of the Applicant Company for the purpose of considering and, if thought fit, approving, with or without modification(s), the proposed Scheme of amalgamation, of CONSUMER FINANCIAL SERVICES LIMITED, into and with L&T HOUSING FINANCE LIMITED, and Their Respective Shareholders and Creditors, is dispensed with in view of the consent given by all the Seven Equity Shareholders of the Applicant Company, which are annexed as **Exhibits 'R' to 'X'** to the Affidavit in support of the Summons for Direction.
2. That convening and holding of the meeting of the Secured Creditor of the Applicant Company for the purpose of considering and, if thought fit, approving, with or
