1. Heard learned counsel appearing for the respective parties.
2. It is not in dispute that the Judgment of the Division Bench of this Court, in Writ Petition No.4996 of 2012 and connected writ petitions, has been set aside by the Honourable Apex Court in its Judgment in the case of **University Grants Commission and anr ..vs.. Neha Anil Bobde (Gadekar)** reported at **(2013)10 SCC 519**.
3. This Court had adjourned the matters even thereafter because of the requests made by the parties pointing out that review of that Judgment has been sought before the Honourable Apex Court.
4. Today, it is not in dispute that the review petition is also dismissed.

5. Learned counsel appearing for the respective parties, however, state that a curative petition has now been filed and it is pending.

6. Learned counsel for the respondents are opposing any adjournment.

7. As the Judgment of this Court is already set aside by the Honourable Apex Court and the review is also dismissed, we are not inclined to adjourn the matters further.

8. Accordingly, in the light of the Judgment of the Honourable Apex Court cited *supra*, these writ petitions are disposed of.

9. Needless to mention that, in case the curative of petition is granted by the Honourable Apex Court, respective petitioners can renew their requests before this Court.
