ORDER

Petition filed under Section 439 Cr.P.C.

2. Petitioner is the accused in Crime No.27/2014 of Kollam Excise Range registered for the offence punishable under Section 22(c) of the NDPS Act.

3. The allegation against the petitioner is that on 13.10.2014 at 6.15 p.m., he was found in possession of 49 ampule of Buprenorphine, which is a psychotropic substance, in contravention of the provisions of the NDPS Act. The petitioner has been in custody for the period from 13.10.2014 onwards.

4. Heard learned counsel for the petitioner and the learned Public Prosecutor.

5. This is a case in which commercial quantity of psychotropic substance is involved. The allegations against the petitioner are very grave and serious. It seems that the investigation is over and the final report has already been filed. Considering the facts and circumstances of the case and the seriousness of the allegations against the petitioner, I am satisfied that the petitioner is not entitled to be enlarged on bail.

6. In the result, this Bail Application is dismissed. When the final report has been filed in the matter, the court below shall take immediate necessary steps to dispose of the case, as expeditiously as possible.
